#### Welcome

The Tokyo Organising Committee of the Olympic and Paralympic Games (Tokyo 2020) has developed a medical services programme dedicated to providing comprehensive medical care during the Olympic and Paralympic Games Tokyo 2020. This Pharmacy Guide contains the definitive list of medicines available from the Polyclinic Pharmacy, with comprehensive prescribing information for each drug, and details of the procedures for the prescribing and supply of medicines to individuals requiring medical treatment.

The medicines listed in this guide will be provided to athletes and other accredited individuals free of charge. Medicines should be prescribed in quantities required for immediate and necessary care for the duration of the Games - the Tokyo 2020 Chief Medical Officer reserves the right to review each prescription with regard to an appropriate quantity. Any individual with an existing medical condition is advised to bring a sufficient amount of medicine with them to cover the duration of their visit to Japan and their travel home. If a National Olympic Committee (NOC) team doctor wishes to prescribe a medicine not included in this Pharmacy Guide, every effort will be made to facilitate the availability of the medicine. However, the prescription will be at the cost of the NOC.

The medicines listed in this guide are classified according to the World Anti-Doping Agency (WADA) 2020 Prohibited List for use in-competition as either "Not Prohibited", "PROHIBITED", or "Prohibited in particular sports". Special procedures are in place at the Games for the prescribing of medicines to athletes that are classified as "Prohibited". All athletes and healthcare professionals involved in prescribing or administering medicines should familiarise themselves with the World Anti-Doping Code and the WADA 2020 Prohibited List.

Particular care should be taken when a prescription is written for a prohibited substance. This requires a Therapeutic Use Exemption (TUE), which must be approved first by the Therapeutic Use Exemption Committee (TUEC). Information on the prohibited status of any particular medicine purchased in Japan can also be found on the Global Drug Reference Online (Global DRO) website at <a href="https://www.globaldro.com">www.globaldro.com</a>

Due to the nature of temporary registration, NOC team doctors are restricted to caring for members of their own delegation, or to members of other specified delegations where a prior agreement in writing has been submitted to Tokyo 2020.

#### **Essential information**

Tokyo 2020 will provide pharmacy services at the Olympic Villages only. At other sites, necessary medical supplies will be prescribed upon medical examination by the Tokyo 2020 doctors at the medical stations.

### Village polyclinic pharmacy

A pharmacy will be located within the Olympic Village. The pharmacy will be open from 7:00 to 23:00 daily. Outside of these hours, medicines for immediate and necessary care will be provided by the emergency doctor.

The pharmacy will provide the medicines listed in this Pharmacy Guide free of charge to individuals as part of the medical treatment for acute or the acute exacerbation of chronic medical conditions. Medicines will be dispensed on an immediate and necessary basis, by prescription only. Any individual with an existing medical condition is advised to bring a sufficient amount of medicine with them to cover the duration of their visit to Japan and their travel home.

A comprehensive medicines information service will be provided at the Polyclinic Pharmacy. Athletes and team officials in the Olympic Village will have access to the Polyclinic Pharmacy. The medicines information service should be accessed in person, and will offer information on topics such as:

- clinical drug information
- · international or foreign medicines
- poisons and toxicology information
- prohibited status of drugs in sport
- prescribing procedures

### Satellite village medical station pharmacies

The Sailing Village and The Cycling Village; TBD

### Registration of team doctors

NOC team doctors must register in advance with Tokyo 2020 to provide medical services to members of their delegation during the Games. Registration is free of charge. Full details of the registration process will be sent to NOCs in August 2019.

Team doctors who are registered with Tokyo 2020 should write prescriptions for members of their own delegation, or members of other specified delegations where a prior written agreement between NOCs has been submitted to Tokyo 2020. These medicines prescribed by NOCs are provided at the Polyclinic Pharmacy (or at the Satellite Village Medical stations; TBD) free of charge.

Tokyo 2020 assumes no responsibility for any healthcare provided by NOC healthcare personnel to NOC team members and delegates. Tokyo 2020 will not provide malpractice or liability insurance for NOC healthcare personnel. It is recommended that NOC healthcare professionals inform their insurance company that they are travelling abroad with a sports team and check whether their malpractice insurance covers this activity.

#### Import and export of medicines

Prior application through Tokyo 2020 is required to the Ministry of Health, Labour and Welfare's Regional Bureau of Health and Welfare that has jurisdiction for the port of entry at which the medicines will be imported into Japan. This will enable the NOC team doctors to bring in medicines and medical equipment for their team members.

The medicines and medical devices to be brought into Japan for a team's use should be imported as accompanied luggage with the team doctor or sent as unaccompanied luggage. (Over-the-counter drugs, prescription medicines, and cosmetic products to be used by individual members must be carried by the individual; a separate application may be required in order to bring over a certain amount. For details, please check the Tokyo 2020 Customs and Freight Forwarding Guide.)

All medicines and medical devices imported into Japan according to the application form must be appropriately utilized and managed under the care of the team doctor, during the team doctor's stay. All items, except for those consumed during the time spent in Japan, must be carried out of Japan with the registered team doctor.

The import into Japan of psychoactive drugs and narcotics for medicinal use by a delegation is not permitted. A separate application for personal use is required. For details, please check the Tokyo 2020 Customs and Freight Forwarding Guide. The import into Japan of medical cannabis and stimulants (including raw materials) is not permitted under any circumstances.

#### Storage and safe use of team medicines

NOC healthcare personnel are responsible for the storage and safekeeping of their delegation's medicines and supplies. Tokyo 2020 is not responsible for, and shall bear no liability relating to or arising out of, the storage or monitoring of the supplies and medicines by the NOC.

Medicines should be stored in a secure locked receptacle and kept in the original packaging until used, and should only be administered to members of the prescribing NOC doctor's delegation (unless a written agreement exists between two NOCs). NOC doctors should ensure that robust systems are in place to ensure the safe and secure handling of medicines in their possession.

### Prescriptions prescribed by NOC team doctors

Prescription forms must be collected in person by the doctor who will use them. Prescription forms will be available from the Polyclinic Pharmacy in the Olympic Village. Prescription forms will only be issued to doctors who are registered with Tokyo 2020. NOC team doctors are only permitted to prescribe medicines to members of their own delegation, unless a prior written agreement exists between NOCs and has been submitted in writing to Tokyo 2020.

Medicines will be provided by the Polyclinic Pharmacy (and Medical station pharmacies in the satellite villages; TBD) when the details have been written on official Tokyo 2020 prescription forms by accredited NOC team doctors registered to prescribe in Japan. All prescriptions must be written in English. Up to seven (7) days supply, or a small complete pack of medicine, will generally be provided with a single prescription. Further supplies will normally require a subsequent prescription. Antibiotics should be prescribed in sufficient quantities to treat the medical condition. Pharmacists will call the prescriber if any concerns arise — including prescriptions for more than seven (7) days. The original prescription will be kept in the pharmacy.

All information on prescriptions must be clearly and legibly printed. Please avoid Latin and abbreviations.

The following information must be included on the prescription (TBD)

- · date of issue
- patient's information;
   (name, date of birth, gender, accreditation number, sport, athlete or not, NOC)
- prescriber's information;
   (name, accreditation number, registration number, contact number)
- name of medicine, dosage form and unit strength (for example: Paracetamol tablets 500mg)
- quantity (for example: TBD)
- directions for use (for example: TBD)
- prohibited substances declaration where applicable (see below)

#### Narcotics, cannabis and stimulants

Narcotic drugs, such as morphine and ketamine, should be prescribed by Tokyo 2020 doctors with the necessary qualifications. If a NOC team doctor wishes to prescribe narcotic drugs, they are required to consult with a qualified Tokyo 2020 doctor.

Please also note that medical cannabis and stimulants (including raw materials) should not be imported into Japan even if athletes hold a valid Therapeutic Use Exemption (TUE).

### Prescribing a prohibited substance and TUEs

Prohibited substances are drugs that, according to the WADA 2020 Prohibited List, should not be used by athletes who will be competing in the Olympic Games, unless a Therapeutic Use Exemption (TUE) has been granted by an appropriate Therapeutic Use Exemption Committee (TUEC) or, in the case of an emergency during the Games period, a retroactive TUE application has been submitted to the TUEC following the necessary treatment.

Prescribing prohibited substances for athletes should be avoided unless a TUE is obtained in advance, or in medical emergencies when an athlete's health takes absolute priority and a retroactive TUE should be obtained (for example, for opiates for pain relief, or adrenaline (epinephrine) for anaphylaxis).

If a TUE has already been obtained from the TUEC before the prescription has been written, a copy of the TUE documentation should be presented to the dispensing pharmacist, who will then dispense the medicine for the athlete.

### Prescribing procedure for prohibited substances

- In an emergency, a doctor must administer all necessary treatment to an athlete, including using prohibited substances and methods if clinically required, and must apply for a retroactive TUE afterwards.
- If it is not an emergency, the prescribing doctor must explain to the athlete that a prohibited substance is being prescribed and must explain the consequences if a TUE is not obtained in advance. A written TUE will subsequently need to be submitted.
- The prescribing doctor and the athlete who is receiving the medication must sign the prescription to confirm that they are aware of the status of the substance.
- The dispensing pharmacist must confirm with the prescribing doctor that the substance is a prohibited substance and must also confirm that they wish to proceed to prescribe the substance.
- The pharmacist should sign the prescription to verify that he/she has informed the prescribing doctor and the athlete that the substance is prohibited.

# **IOC Needle Policy & Rules**

The Tokyo 2020 Medical Services department follows the IOC needle policy regarding the use of injections in the treatment of athletes and the safe disposal of medical materials by NOCs.

#### **Available Medicines**

Please note that intravenous infusions and/or injections which exceed a total of 100 mL per 12 hour period are PROHIBITED, except for those legitimately received in the course of hospital treatments, surgical procedures or clinical diagnostic investigations.

The information in this list is based on the World Anti-Doping Agency (WADA) 2019 Prohibited List. This list will be updated in accordance with WADA 2020 Prohibited List in time for the Tokyo 2020 Games.


