Minutes: Franz Schreiber

ITEM 1 Welcome

The President of ISSF, Mr. Olegario Vázquez Raña, expressed a friendly welcome to the reelected members of the Administrative Council and in particular to those members who had been newly elected into the Administrative Council.

Due to the delay caused by the election process during the General Assembly Mr. Vázquez hoped that the elections in this meeting will not take that long.

ITEM 2 Roll-Call

Mr. Schreiber welcomed the newly awarded Honorary Member, Mr. Jacques Trouvé, who attended the 2nd Council meeting as observer, without voting power. The other Honorary Members were not able to come to the meeting and they extended their greetings to all Administrative Council members.

The Secretary General reported that the new Administrative Council has a total of 35 members. However Mr. Pekka Kuusisto and Mr. Juha Hirvi excused themselves and after the Roll Call was collected it was noted that Dr. Ahmed Al Raisi was also not present. Therefore the Council was represented with 32 votes.

Mr. Schreiber informed that the procedure for this Council meeting would be a little different due to the time pressure to meet the dinner appointment with the special guest of honor, IOC President Dr. Thomas Bach at 19:00 hours. The Secretary General and the President proposed to distribute the different voting ballots, collect them and while the scrutinizers are counting the meeting should be continued with the next agenda items without waiting for each committee result. Mr. Schreiber hoped that then the results can be announced at the end of the meeting and reported that alternatively they will be announced during the dinner in the evening and of course the results would be published on the ISSF webpage. Due to the special honor of having Dr. Bach for dinner the President and Secretary General hoped that the Council members can agree to this procedure. Mr. Schreiber asked if there are any objections to this proposal. No objections had been expressed, so the President continued with the next agenda item.
