



ISSF Privacy Policy

The International Shooting Sport Federation e.V., Bavariaring 21, 80336 Munich, Germany (“ISSF”) is the service provider and responsible authority of the ISSF Website. The ISSF is committed to protect your privacy and personal data and ensure your security when using its website and services. ISSF strives to be transparent about how we collect and use your information and to keep your information secure. Throughout this Privacy Policy “Personal Data” means any information relating to an identified or identifiable natural person, e.g. name, address, IP address etc. Please note that ISSF Website services are not direct to children below the age of sixteen. ISSF does not knowingly collect, use, or share information that could reasonably be used to identify children under age of sixteen without prior parental consent or consistent with applicable law. Any registration by a minor would require the parents’ prior consent.

In the following, ISSF informs you on the processing of Personal Data when you are using the ISSF Website or any service offered on the ISSF Website.

1. Processing of Personal Data

a) Visiting the ISSF Website

ISSF temporarily processes the following information when you are visiting the ISSF Website: IP address, date and time of the request, time zone difference to Greenwich Mean Time (GMT), content of the request (concrete webpage), access status/http-status code, respective size of transferred data, website the request has come from, the operating system and its interface, language and version of the used browser software, videos viewed/audio tracks listened to, individual links clicked, search words or search phrases (site search), duration of visit.

Such information is anonymized and used to ensure a smooth connection setup of the website, analyse trends, administer the website, track users’ movements and gather broad demographic information for aggregate use, which allows ISSF to improve the ISSF Website to its visitors needs, to ensure the ISSF Website functions correctly and to identify any technical issues as well as for statistical purposes. In addition, the IP address is processed for security reasons, e.g. to identify cyber attacks against the ISSF Website.

Article 6 para. 1 lit. f of the General Data Protection Regulation (“GDPR”) serves as the legal basis for such processing. Our legitimate interest follows from the purposes of data use listed above. Such information is neither used to create individual user profiles (“Profiling”) nor forwarded to third parties unless required by state authorities on basis of legal provisions. Please do not visit the ISSF Website if you do not want to be subject to such anonymized use of data.

b) Use of Cookies

Cookies are small text files which are sent to your computer by a web server and saved on your hard drive so that the web server can “remember” you. The use of Cookies serves our legitimate interests according to Art. 6 para. 1 lit. f GDPR as explained below. Furthermore, by clicking „OK“ at the first visit of the ISSF Website you gave consent to the use of cookies. Therefore, also Article 6 para. 1 lit. a GDPR serves as the legal basis for the use of cookies. You have the possibility to deactivate the use of Cookies as described below with regard to the respective type of Cookies.

aa) ISSF Website’s Cookies

The ISSF Website uses Cookies and active components (e.g. JavaScript) to remember

- preferences and to customise the design of the websites,
- already seen infographics pop-ups, so it will not be displayed again for a time,
- your online shopping bag during your shopping activity at the ISSF online shop.

The cookie-related information is not used to identify you personally and the pattern data is fully under ISSF's control. These Cookies are not used for any purpose other than those described here. You may, at any time, prevent the setting of Cookies through the ISSF Website by means of a corresponding setting of your internet browser, and may thus permanently deny the setting of Cookies. Furthermore, already set Cookies may be deleted at any time via your internet browser which is possible in all common internet browsers. The deactivating of the ISSF Website's Cookies could, however, affect the proper functioning of the ISSF Website in your internet browser.

bb) Google Analytics

The ISSF Website uses Google Analytics, a web analytics service provided by Google, Inc., 1600 Amphitheatre Pkwy, Mountain View, CA 94043-1351, United States ("Google"). IP anonymization is activated which means that Google will anonymize the last octet of the IP address for Member States of the European Union as well as for other parties to the Agreement on the European Economic Area. Google Analytics uses Cookies to help the website analyse how users use the site. On behalf of the website provider Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage to the website provider. The information generated by the cookie about your use of the ISSF Website (including your IP address) will be transmitted to and stored by Google on servers in the United States. Google will not associate your IP address with any other data held by Google. Google Analytics is switched off once you log-in to ISSF Website services which require your registration.

c) ISSF online shop

If you want to place an order at the ISSF online shop on the ISSF Website you need to provide ISSF with your name and your address-data, including e-mail-address and payment related data in order to allow us to perform the contract with you. Such data is used as necessary for the performance of the contract and stored for the time necessary in such context, e.g. to allow us the assessment of possible warranty rights, or according to retention periods as legally required, e.g. pursuant to ISSF's commercial and tax law obligations. Therefore, such processing is primarily based on Article 6 para. 1 lit.b GDPR.

d) ISSF News Magazine

ISSF regularly processes the name, the address and the email address of ISSF News Magazine subscribers. Such data is used as necessary for concluding and performing under the respective contract with the subscriber, in particular for delivering the ISSF News Magazine and invoices. Therefore, Article 6 para. 1 lit. b GDPR serves as the legal basis for such processing of Personal Data.

e) ISSF Forum and intranet

The use of the ISSF Forum will require further processing of Personal Data by the ISSF. In particular, the following information will be processed: name, address, e-mail-address, date of birth, IP address, all communication made by you on the ISSF Forum.

This information is required to identify the participant's legitimation, to create and manage your account, to provide for a safe login and forum environment, to monitor the ISSF Forum's content to its compliance with legal provisions and, if necessary, to contact you via your registered contact information in connection with the management and operation of your account. Therefore, such processing is primarily based on Article 6 para. 1 lit.b GDPR.

Upon registration to the ISSF Forum you agree to the processing of your Personal Data for the time of your participation in the ISSF Forum. Therefore, also Article 6 para. 1 lit.a GDPR may serve as the legal basis for processing the abovementioned Personal Data in connection with your use of the ISSF Forum. In case of failure to provide such data, participation in the ISSF Forum will not be granted. However no other disadvantages will occur when the necessary data is not provided. You may un-register from the ISSF Forum at any time by informing the ISSF Forum 2024 Operator (for contact details see the ISSF Forum 2024 - Terms and Conditions). Upon unregistration your Personal Data will usually be deleted within six months.

With regard to the use of your Personal Data the same applies to the ISSF Website's intranet. You may un-register from the intranet at any time by informing privacy@issf-sports.org.

f) Newsletters and press releases

Upon your subscription the ISSF may use your Personal Data to provide you with information via its newsletter and press releases. Upon unsubscription your Personal Data will usually be deleted within six months.

For marketing purposes, the ISSF may monitor whether you open and/or click on URLs in our newsletters in order to notify you about products and events which might be in your interest. Article 6 para. 1 lit.f GDPR serves as the legal basis for processing your Personal Data in this context as such data processing for direct marketing activities are covered by the legitimate interests of ISSF. Your

interests do not outweigh ISSF's interests as ISSF does not use any data of special category. Such use of your data complies with your reasonable expectations as the ISSF services are offered free of costs and our marketing activities do only relate to the world of shooting sport. In addition, you can object to the use of your data for direct marketing purposes at any time as pointed out below at the section regarding your rights.

2. Links to third parties' websites

The ISSF Website may provide links to third-parties' websites for the convenience of our users. If you access those links, you will leave the ISSF Website. ISSF does not control these third-party websites and cannot represent that their policies and practices will be consistent with this Privacy Policy. For example, other web sites may collect or use personal information about you in a manner different from than described in this document. Therefore, you should use other web sites with caution, and you do so at your own risk. ISSF encourages you to review the privacy policy of any web site before submitting personal information. It is also likely that your data will be transferred to different countries, in particular the United States of America, which might not have standard of data protection as your home country. The third party service is also likely to use cookies. In order to get information on the purpose and scope of data collection and procession by the third party websites provider, please consult the respective privacy policy of that provider.

3. Information on the transfer of Personal Data

ISSF does not sell, rent, or lease any individual's Personal Data to anyone for marketing purposes, and will take commercially reasonable steps to maintain the security of this information. However, the ISSF reserves the right to supply any such information to any organisation into which it may merge or change in the future. ISSF only discloses your Personal Data to third parties, if

- you gave explicit consent pursuant to Article 6 para. 1 lit.a GDPR;
- the disclosure is required pursuant to Article 6 para. 1 lit.f GDPR to assert, exercise or defend legal claims and there is no reason to believe that you have an overriding interest in not disclosing your data;
- ISSF is obligated pursuant to Article 6 para. 1 lit.c GDPR to release your personal information pursuant to judicial or other government subpoenas, warrants, or other orders or
- it is lawful and pursuant to Article 6 para. 1 lit.b GDPR required for the performance/settlement of contractual relationships with you.

The ISSF Website's main database is located in Germany. ISSF Website's back-up servers are located in Switzerland where, according to the European Commission, an adequate level of data protection is ensured. ISSF only transfers your Personal Data to other third states outside the European Union if (i) you have consented to such transfer after having been informed of the possible risks of such trans-

fer due to the absence of an adequacy decision or other appropriate safeguards, or (ii) the transfer is necessary for the performance of services in relation with the ISSF Website or the implementation of pre-contractual measures taken at your request, or (iii) the transfer is necessary for the performance of a contract conclude in your interest between ISSF and another natural or legal person, or (iv) one of the other conditions stipulated in Article 49 para. 1 GDPR applies.

4. Information about and access to your Personal Data

In the following the ISSF informs you about your rights of information about and access to your Personal Data.

a) Right of access

Pursuant to Article 15 GDPR you have the right to obtain from the ISSF confirmation as to whether or not Personal Data concerning you is being processed. Where that is the case, you have the right to access the collected data and the following information: The source and the recipients of the data, the purpose of its processing and information about your rights as provided here under Number 4. Upon request a copy of such information shall be provided to you free of charge, any further copies may be provided in exchange for a reasonable fee based on administrative costs.

b) Right to rectification

Pursuant to Article 16 GDPR you have the right to obtain from the ISSF without undue delay the rectification of inaccurate Personal Data concerning you. Taking into account the purposes of the processing, you have the right to have incomplete Personal Data completed, including by means of providing a supplementary statement.

c) Right to erasure

Pursuant to Article 17 GDPR you have the right to obtain from the ISSF the erasure of Personal Data concerning you without undue delay once the ISSF does not have further legal grounds for processing your data.

d) Right to restriction of processing

Pursuant to Article 18 GDPR you have a right obtain from the ISSF restriction of processing when there is uncertainty over either the accuracy of the data process, the lawfulness of the data process or the effectiveness of your withdrawal of consent. You may also obtain restriction when the ISSF no longer needs the Personal Data, but they are required by you for the establishment, exercise or defence of legal claims. Restriction means that such Personal Data shall, with the exception of storage, only be processed with the data subject's consent or for the establishment, exercise or defence of legal claims or for the protection of the rights of another natural or legal person or for reasons of important public interest of the Union or of a Member State.

e) Right to data portability

Pursuant to Article 20 GDPR where the data has been provided based on your consent or on a contract and the data processing is carried out by automated means, you have the right to receive the Personal Data, which you have provided, in a structured, commonly used and machine-readable

format and have the right to transmit those data to another controller without hindrance from the ISSF.

f) Right to object

Pursuant to Article 21 GDPR you have the right to object, on grounds relating your particular situation, at any time to processing of your Personal Data, when

- processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the ISSF (Article 6 para. 1 lit.e GDPR) or
- processing is necessary for the purposes of the legitimate interests pursued by ISSF or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of Personal Data, in particular where the data subject is a child (Art. 6 para. 1 lit.f GDPR).

When you object the ISSF may only process your data if compelling legitimate grounds are demonstrated. Irrespective of this you may object at any time to processing of Personal Data for marketing purposes.

g) Right to revoke consent

Where the processing of your data is based on your consent, you have the right to withdraw consent at any time by informing privacy@issf-sports.org. This, however, does not affect the lawfulness of processing based on your consent before the withdrawal.

h) Right to lodge a complaint

Pursuant to Article 77 GDPR you may at any time lodge a complaint with a supervisory authority.

5. Data Security

The ISSF takes data security very seriously. Taking into account the state of the art, the costs of implementation and the nature, scope, context and purposes of processing, as well as the risk of varying likelihood and severity for your rights and freedoms, the ISSF implements appropriate technical and organisational measures to ensure a level of security which is appropriate to the represented risk.

6. Amendments

ISSF reserves the right to update this data privacy policy from time to time. Updates of this privacy policy will be published on this website. Any changes to this privacy policy apply as of their publication on our website. ISSF therefore recommends that you visit this website regularly so that you are appropriately informed about any updates and changes.
