#### **Minutes**

#### ITEM 1 Welcome

President Olegario Vázquez Raña welcomed all members of the ISSF Administrative Council to the meeting of the ISSF Administrative Council II, where the members of the ISSF Section Committees would be elected.

#### ITEM 2 Roll-Call

Mr. Franz Schreiber, ISSF Secretary General reported that all members of the ISSF Administrative Council were present, only Mr. Li Feng was missing. So the number of votes was 34 and as soon as Mr. Li Feng was back, the Administrative Council was complete. Mr. Li Feng returned to the meeting room and excused his delay. Mr. Nick Sullivan was excused and had sent Mr. Ewen Pirie, President of the New Zealand Shooting Federation Inc. to act on his behalf.

The Administrative Council was represented by 35 members.

#### ITEM 3 Election of Scrutinizers

The President proposed the following scrutinizers:

The members of the ISSF Administrative Council unanimously approved the scrutinizers.

#### ITEM 4 Elections of Members of Section Committees for the period of 2 years

The President gave the floor to the Secretary General who explained that some applications were received too late or the candidate did not hold the required Judges License. Those applications could of course not be taken into consideration and were not included in the list of candidates that was sent to all Member Federations. So all Federations could check if their candidates were on the list or not. The ISSF had not received any objections from Member Federations so the Secretary General assumed that the list was complete. A total of 13 applications were not sent in time and could therefore not be accepted. One candidate did not hold a Judges License and in one application, no name was entered. The Secretary General explained that all those invalid applications were not included in the list but if the members of the Administrative Council wished to have the names, he could give them to the Administrative Council members later. The Secretary General stated that the list of candidates and the Curriculum Vitae were circulated prior to the meeting, and were also enclosed in the documents and he therefore assumed that it was not necessary to present the candidates but could directly start with the voting of the Committee members. Mr. Schreiber explained that the President had decided that the Chairman of each Committee should give a short summary and mention those who had worked for the Committee and if the Chairman was satisfied with their work or report on anything the Chairman thinks is worth mentioning and that is of interest for the members of the Administrative Council to help them in their decision whom to vote. Mr. Schreiber pointed out that according to the Constitution, each Section Committee must have at least one female candidate. If no female candidate is elected, the number of committee members will be reduced to six (in the Technical

Committee only four members) and another female candidate would be added to the committee later.

The President asked if there were any questions. Since there were no questions, the President announced the start of the election.

#### ITEM 4.1 Technical Committee

Mr. Schreiber explained that the voting papers would be distributed and asked the Chairman of the ISSF Technical Committee, Mr. Jörg Brokamp to give some comments. Mr. Brokamp took the floor and gave some explanations.
